### **CCSD Board of School Trustees meeting recap**

Trustees receive update on COVID-19 and CCSD's Response.

#### LAS VEGAS - Agenda Item 5.02 - COVID-19 Update

The Clark County School District (CCSD) Board of School Trustees received an update on COVID-19 and the District's response.

Trustees reviewed the latest health numbers available from the Centers for Disease Control and local health authorities in regard to the risk of transmission in schools.

The Southern Nevada Health District's Acting Chief Health Officer Fermin Leguen provided information on the current test positivity rate and recommendations to allow students back into the classroom in some form.

The presentation also included a discussion of a potential phased transition plan from distance education. Trustees did not vote on any plans or discuss a start date for the transition plans.

Trustees inquired and commented on several health-related topics and other items connected to the transition into hybrid or face-to-face instruction, including staffing levels and options, safety and cleaning protocols, building capacity and ventilation, communication and community involvement, among others.

Trustees also shared information on other districts' current education plans and highlighted the importance of detailed and planned action moving forward. They requested items for inclusion and consideration in any transition action.

The Board will consider transition plans on November 12, 2020 for a potential vote.
